RESOLUTION APPROVING THE PROPOSED SUPPLEMENTAL ANNUAL INVESTMENT PLAN 2017 FROM THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR FROM THE EXCISE TAX ON LOCALLY MANUFACTURED VIRGINIA-TYPE CIGARETTES UNDER RA 7171 & RA 8240, FROM THE DEPARTMENT OF AGRICULTURE (DA) AND FROM THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) INVOLVING A TOTAL APPROPRIATION OF ONE BILLION SIX HUNDRED FIFTY MILLION PESOS (1,650,000,000.00)

WHEREAS, presented for consideration of this Body is the proposed supplemental budget from the direct share of the Municipality of Narvacan, Ilocos Sur from the excise tax on locally manufactured Virginia-type cigarettes under RA 7171 and RA 8240, from the Department of Agriculture (DA) and from the Department of Public Works and Highways (DPWH) involving a total appropriation of ONE BILLION SIX HUNDRED FIFTY MILLION PESOS (1,650,000,000.00)

WHEREAS, the fund shall be utilized to advance the self-reliance of local tobacco farmers through the following projects: a) livelihood projects enhancing the tobacco farmers' income including those that will promote, enhance and develop the tourism potential of tobacco-growing provinces, b) projects undertaken by cooperatives that will enhance better quality of products, increase productivity, increase farmers' revenues as well as take account of cooperative programs to assist tobacco farmers in planting alternative crops or implementing other livelihood projects, c) agro-industrial projects involving the tobacco farmers in the management and subsequent ownership of these projects and, d) infrastructure projects such as farm-to-market roads, schools, hospitals and rural health facilities;

WHEREAS, the aforesaid programs and projects to be implemented are included in the approved Annual Investment Program of the Municipality of Narvacan, Ilocos Sur;

NOW THEREFORE, after careful analysis and deliberations on the premises presented, and on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to enact the following Appropriation Ordinance to wit:
