RESOLUTION ADOPTING THE SUSTAINABLE DEVELOPMENT GOALS (SDGs), SENDAI FRAMEWORK, PHILIPPINE DEVELOPMENT PLAN (PDP) 2017-2022, ILOCOS REGION DEVELOPMENT PLAN (RDP) 2017-2022, REGIONAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (RDRRMP), NATIONAL SECURITY POLICY (NSP), AND PROVINCIAL DEVELOPMENT AND PHYSICAL FRAMEWORK PLAN (PDPFP)- ALIGNED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) OF THE MUNICIPALITY OF NARVACAN, PROVINCE OF ILOCOS SUR


WHEREAS, Pursuant to the provision of the Local Government Code of 1991 and existing planning guidelines, each LGUs shall prepare the following plans: PDPFP by provinces, Comprehensive Land Use Plan (CLUP) and Comprehensive Development Plan (CDP) with their corresponding implementation instruments by cities and municipalities; and Barangay Development Plan (BDP) for barangays along with NGA-mandated thematic plans and sectoral plans;

WHEREAS, the municipality has formulated its CDP covering the period 2012-2018 duly approved on June 17, 2013 and subsequently adopted its Local Development Investment Program (LDIP) by virtue of SB Resolution No. 14 dated June 17, 2013 ;

WHEREAS, The Philippine Development Plan (PDP) 2017-2022, anchored on AmBisyon 2040 and the National Security Policy (NSP) 2017-2022 has recently been approved and these, together with the country's international commitments to include the achievement of Agenda 2030, the Sustainable Development Goals (SDGs) and the Sendai Framework for Disaster Risk Reduction should be duly considered in the local planning process to ensure that national government strategic priorities and development thrusts are cascaded to sub-national levels down to LGUs and are reflected in the local development plans and programs;

WHEREAS, recent policies also require mainstreaming of special thematic and sectoral concerns including, among others, Disaster Risk Reduction and Climate Change Adaptation (DRR-CCA), Conflict-Sensitivity and Peace Promotion (CSPP) and Gender and Development (GAD) concerns in local development plans;
