**RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR, HONORABLE ZURIEL S. ZARAGOZA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF NARVACAN WITH THE DEPARTMENT OF AGRARIAN REFORM REPRESENTED BY UNDERSECRETARY SYLVIA P. MALLARI (DAR), AND THE BRIDGES MANAGEMENT CLUSTER-UNIFIED PROJECT MANAGEMENT OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REPRESENTED BY PROJECT DIRECTOR GIL R. VILLANUEVA (BMC-UPMO) CONCERNING THE CONSTRUCTION OF KAKALDINGAN BRIDGE LOCATED AT BARANGAY LUNGOG, NARVACAN, ILOCOS SUR**

**WHEREAS**, the Municipality of Narvacan has been advised by the Department of Agrarian Reform through its Provincial Office regarding the provision of the latter support programs to address developmental needs of agrarian reform beneficiaries including the provision of physical infrastructure through its program "Tulay ng Pangulo Para sa Kaunlaran Pañg-Agraryo Project (TPKP);

**WHEREAS**, the tripartite agreement also involves the participation of the Department of Public Works and Highways through the preparation of detailed engineering plans Estimates and Program of Work and its implementation;

**WHEREAS**, the Local Government Code empowers LGUs to work in partnership with various stakeholders, both government agencies (GAS) and non-government organizations (NGOs) to address much needed public services such as this project;

**WHEREAS**, the execution of this memorandum of agreement shall ultimately redound to the benefit of the constituents of the Municipality of Narvacan, most especially those in remote areas where the project is located;


**WHEREAS**, Sec. 455, paragraph (b), sub-paragraph 1 (vi) of RA 7160 provides that the Local Chief Executive is mandated to represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance;

**NOW, THEREFORE**, on motion duly seconded **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to grant authority to the Local Chief Executive of the Municipality of Narvacan, to enter into and sign a Memorandum of Agreement, for and in behalf of the Municipality of Narvacan, Ilocos Sur (LGU) with the Department of Agrarian Reform represented by Undersecretary Sylvia P. Mallari (DAR) and the Bridges Management Cluster – Unified Project Management of the Department of Public Works and Highways represented by Project Director Gil R. Villanueva (BMC-UPMO) concerning the construction of Butel Bridge located at Sitio Kakaldingan, Barangay Lungog, Narvacan, Ilocos Sur;






