RESOLUTION CREATING THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) AT THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, Memorandum Circular No. 2017-36 dated February 24, 2017 from the DILG mandates the creation of Local Youth Development Office (LYDO) at the Province, City and Municipal Levels;

WHEREAS, if said LYDO is created and its office established, it has the following functions as per **R.A. 10742** and its IRR, otherwise known as the **Sangguniang Kabataan Reform Act of 2015**;

1. To register and verify youth and youth serving organizations;
2. Provide technical assistance to the LYDO in the formulation of LYD Plan;
3. Facilitate the election of LYDO representatives;
4. Serve as Secretariat to the LYDO;
5. Conduct the mandatory and continuing training of SK officials;
6. Provide technical and Logistical and other support in the training programs;
7. Coordinate with the Commission with regard to youth programs, and
8. Perform such other functions as maybe prescribed by law, ordinance, or as the LCE, the DILG or in the NYC may require.

WHEREAS, RA 10742, otherwise known as the SK Reform Act of 2015 and its Implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality

WHEREAS, Rule IV, Section 27 of Rules and Regulations Implementing RA No. 10742 or the Sangguniang Kabataan Reform Act of 2015 states that "*The Local Government Unit concerned may provide an office space and/or desk within the province and preferably within the Youth Development Office, upon the request of the commission.*"


WHEREAS, Sangguniang Kabataan Reform Act of 2015 also states that "*Section 27 – Funding. – The Local Government Unit shall incorporate in its annual budget such amount as may be necessary for the operation and effective functioning of the Local Youth development Office and in accordance with the COA accounting and auditing rules and regulations.*"

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to Create the Local Youth Development Office (LYDO) at the Local Government Unit of Narvacan, Ilocos Sur

RESOLVED Further that copies of this Resolution be furnished to all offices concerned for their information and guidance.


