RESOLUTION AUTHORIZING THE CHIEF EXECUTIVE, MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A CONTRACT OF SALE FOR THE PURCHASE OF A PARCEL OF LAND LOCATED AT BARANGAY PANTOC, NARVACAN, ILOCOS SUR THAT WILL SERVE AS RELOCATION AREA FOR DISPLACED FAMILIES OF CALAMITIES

WHEREAS, Republic Act No. 0121 otherwise known as the Philippine Disaster Risk Reduction Management Act of 2010 declares as its policy to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, despite efforts exerted by LGU Narvacan in strengthening the capacities and resilience of barangays located along the shoreline identified as disaster prone areas vulnerable to storm surges, monsoon rains, typhoons and cyclones, in mitigating and preparing for, responding to, and recovering from the impact of these natural calamities, limited resources cannot equal the wrath of nature, houses have been washed out and the remaining in constant danger;

WHEREAS, the LGU is prompted with the emergency relocation of these displaced families;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorized the Chief Executive, Mayor Zuriel S. Zaragoza to enter into a Contract of Sale for the purchase of a parcel of land located at Barangay Pantoc, Narvacan, Ilocos Sur that will serve as Relocation Area for Displaced Families of Calamities.

RESOLVED FURTHER, to furnish copies to all concerned agencies for their information and guidance.




