RESOLUTION NO. 17 Series of 2017

RESOLUTION AUTHORIZING HON. ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) REPRESENTED HEREIN BY ITS PROVINCIAL MANAGER, BEVERLY P. PERALTA, PH. D. TO PURCHASE RICE ON CREDIT UNDER THE RICE LOAN PROGRAM

WHEREAS, Local Government Units are tasked to provide basic social services to the people at all times especially in times of emergencies/calamities;

WHEREAS, to provide basic social services to the people, the Local Government Unit of Narvacan has requested the NFA to allow it to purchase rice on credit for the following purposes: 1) for relief operations whenever a state of calamity is declared in the locality; 2) for stockpiling in preparation for cases of emergencies; and 3) for its rehabilitation program for affected families and infrastructures caused by any disaster;

WHEREAS, the Local Government Unit is authorized to set aside an amount equivalent to five (5%) of the Internal revenue Allotment (IRA) or any amount from the estimated revenue for unforeseen expenditures arising from the occurrence of calamities, provided that such appropriation shall be used only in the area affected by the calamities;

WHEREAS, the Local Government Unit is required to set aside an amount equivalent to twenty percent (20%) of their regular income/general fund for contractual debt servicing pursuant to paragraph (b) of Section 324 of the Local Government code

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur in session duly assembled, and on motion duly seconded, do hereby **RESOLVE AS IT IS HEREBY RESOLVED** to authorize the Authorize Hon. **Zuriel S. Zaragoza,** Municipal Mayor, Narvacan, Ilocos sur to enter into Memorandum of Agreement (MOA) with the **National Food Authority (NFA)** represented herein by its **Provincial Manager, Beverly P. Peralta, Ph. D.** to purchase Rice on Credit under the Rice Loan Program;

RESOLVED FURTHER that a copy of this Resolution be forwarded to **Provincial Manager**, **Beverly P. Peralta**, **Ph. D.**, National Food Authority (NFA), Provincial Office, Bantay, Ilocos Sur, for her information and appropriate action.
