**RESOLUTION IDENTIFYING THE AREA FOR THE CONSTRUCTION OF THE COMMUNITY FISH LANDING CENTER (CFLC), CONFIRMING OWNERSHIP OR LEGAL RIGHT OF THIS LOCAL GOVERNMENT UNIT OVER THE SAME, AND AUTHORIZING THE CITY/MUNICIPAL MAYOR TO ENTER INTO A MOA WITH THE BFAR AND THE PFDA**

**WHEREAS**, the municipality of Narvacan recognizes the invaluable contribution of the fishery sector in its economy;

**WHEREAS**, the municipality of Narvacan has been pre-selected as one of the recipients of fishery post-harvest infrastructure and facilities;

**WHEREAS**, these infrastructure/facilities are in the form of Community Fish Landing Center which is envisioned to hasten access to markets to reduce post-harvest losses and increase income as well as improve science-based monitoring of the condition of the fishing ground and fishery resources.

**WHEREAS**, the municipality of Narvacan will devote and set-aside a parcel of land located in Sulvec, Narvacan, Ilocos Sur, the technical description of which are as follows:

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to allocate and devote the above-mentioned property for the building of a Fish Landing Center in Barangay Sulvec, Narvacan, Ilocos Sur and provide the necessary permits for the same subject to applicable rules and regulation;

**RESOLVED FURTHER**, to grant authority to the Hon. Mayor Zuriel S. Zaragoza, to enter into and sign a MOA, for and in behalf of the municipality, with the Bureau of Fisheries and Aquatic Resources Regional Office No. 1, represented by Regional Director Nestor D. Domenden and the Philippine Fisheries and Development Authority represented by its OIC – General Manager, Atty. Glenn A. Pangapalan pertaining to the establishment of the Community Fish Landing Center (CFLC);

**RESOLVED FURTHERMORE**, that copies of this Resolution be furnished to the Bureau of Fisheries and Aquatic Resources Regional Office No. 1 and the Philippine Fisheries and Development Authority for their information, guidance and reference.




