RESOLUTION REQUIRING ALL BARANGAYS TO SUBMIT THE LIST OF ISSUES AND CONCERNS AT THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR THAT WILL TRANSPIRE DURING THE CONDUCT OF BARANGAY ASSEMBLY.

WHEREAS, Section 397 (b) of RA 7160 or the Local Government Code of 1991, mandates that "the barangay assembly shall meet at least twice a year to hear and discuss the semestral report of the barangay concerning its activities and finances as well as problems affecting the barangay", thus Proclamation No. 260, dated September 30, 2011 declares the last Saturday of March and second Sunday of October as Barangay Assembly Days;

WHEREAS, a Memorandum Circular 2017-31 from the Department of Interior or Local Government (DILG) dated February 13, 2017 mandates all City and Municipal Mayors, Liga ng mga Barangay, Provincial, City and Municipal Chapter Presidents, Punong Barangays, DILG Regional Directors and ARMM Regional Governor the conduct of Barangay Assembly for the First Semester of CY 2017;

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur urges all the Barangays to submit the list of issues and concerns that will emerge during the conduct of Barangay Assembly at the office of the Sangguniang Bayan or the Office of the Secretary to the Sanggunian.




