RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (PHILVOCS) REPRESENTED BY DIRECTOR RENATO U. SOLIDUM FOR THE ESTABLISHMENT OF A STRATEGICALLY LOCATED STRONG MOTION INSTRUMENT IN THE PROVINCE OF ILOCOS SUR

WHEREAS, PHILVOCS is the Philippine government agency mandated to avert disasters arising from geotectonic processes (earthquakes, and related geotectonic phenomena such as faulting, landslides and tsunami) and mitigate risks arising there from through formulation of up-to-date comprehensive disaster preparedness and loss reduction action plans;

WHEREAS, PHILVOCS aims to establish strategically located strong motion monitoring instruments to record strong seismic events as well as gather data that could be used for estimating seismic ground shaking hazards for the implementation of sound engineering design in urban areas;

WHEREAS, LGU Narvacan with its strategic location has been chosen to be one of the Municipalities in the Province of Ilocos Sur where the instrument may be suitably and properly installed;


WHEREAS, this Municipality, Narvacan, Ilocos Sur aware of the benefits that such instrument shall provide in the Province of Ilocos Sur and the country as a whole, permits to allow PHILVOCS to install the same in the Municipality subject to the agreement that both parties will adhere to with respect to the area, location and maintenance of the instrument;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorized the Honorable Municipal Mayor of the Municipality of Narvacan, Province of Ilocos Sur, to enter into a Memorandum of Agreement with the Philippine Institute of Volcanology and Seismology represented by Director Renato U. Solidum for the establishment of a strong motion instrument in the Province of Ilocos Sur.


RESOLVED FINALLY that copies of this Resolution be forwarded to all persons and parties concerned for their information and appropriate action.


