RESOLUTION EARNESTLY REQUESTING SECRETARY MARK A. VILLAR OF THE DEPARTMENT PUBLIC WORKS AND HIGHWAYS, TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE IMPROVEMENT/CONCRETING OF FARM TO MARKET ROADS OF BRGY SAN ANTONIO - RIVADAVIA, NARVACAN, ILOCOS SUR

WHEREAS, the Department OF Public Works and Highways is providing integrated services to ensure the increase in farm productivity as well as real-income of small farmers through the development of various farm to market roads;

Villar of the Department of Public Works and Highway in sharing allocation to finance vital programs and projects in the countryside;
