#### RESOLUTION NO. 04 Series of 2017

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A CONTRACT OF SERVICE WITH THE RGE ENVIRONMENTAL CONSULTANCY SERVICES REPRESENTED BY FORESTER RAMON G. ESTOGUE FOR THE REVISION OF THE EXISTING 10-YEAR SOLID WASTE MANAGEMENT PLAN OF NARVACAN, ILOCOS SUR

**WHEREAS,** all cities and municipalities are required to submit a 10-Year Solid Waste Management Plan to be approved by the National Solid Waste Management Commission pursuant to Section 16 of RA 9003, otherwise known as the Ecological Solid Waste Management Act 2000;

**WHEREAS,** in compliance the Ten (10) Years Ecoligical and Solid Waste Management Plans and Programs of the Municipality of Narvacan, Ilocos Sur (2013 – 2022) was passed and approved to ensure an efficient and effective management of solid wastes generated within its jurisdiction;

**WHEREAS**, based on existing regulations and updates, the same needs to be revised to conform to the current standard guidelines and directives set forth by law relative to the gathering of relevant data in consonance to the annotated Outline forwarded by the National Solid Waste Management Secretariat including the data on Waste Analysis Characterization Study (WACS) to be conducted by the Municipality;

**WHEREAS,** the Solid Waste Management Team of Narvacan recommends the hiring of an expert consultant in Solid Waste Management to assist in the preparation of the revision of the 10 year plan;

**WHEREAS,** a duly registered consultancy services at the DTI and BIR signified its intention to contract the preparation of said plan taking into consideration his experience during his stint at the DENR, EMB as in charge of the Solid Waste Management Section;

**WHEREAS**, the Contractor, Forester Ramon G. Estogue, was previously the Officer-In-Charge of the DENR-EMB Solid Waste Management Section, thereby considering his experience and is therefore fit to be hired as technical consultant in the preparation of the 10-Year Solid Waste Management Plan, including the data and his recommendation in the Waste Analysis Characterization Study (WACS);

**NOW THEREFORE,** for and in consideration of the foregoing premises and mutual covenant herein after set forth, the Sangguniang Bayan in session, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor Zuriel S. Zaragoza to enter into a Contract of Service with the RGE Environmental Consultancy Services represented by Forester Ramon G. Estogue and in consideration of NINETY THOUSAND PESOS (P 90,000.00) as compensation of the Contractor under the terms and considerations contained in the Contract of Service.
