RESOLUTION NO. 33 Series of 2018

A RESOLUTION AUTHORIZING THE USE OF THE 30% QUICK RESPONSE FUND FROM THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND FOR RELIEF AND RECOVERY OPERATION EXPENSES RELATED TO THE CALAMITY (TYPHOON OMPONG)

WHEREAS, powerful winds, torrential rains, and colossal ocean waves caused by typhoon 'OMPONG' devastated the whole town of Narvacan, Ilocos Sur;

WHEREAS, SB Resolution No. 32, Series of 2018 declared the town under a state of calamity;

WHEREAS, the Narvacan Disaster Risk Reduction and Management team (NDRRM) was in full force to effect pre-emptive evacuation before the onslaught of typhoon 'Ompong', rescued barangay folks during the height of the storm and gave prompt and quick response assistance on the aftermath of the calamity;

WHEREAS, RA 10121 otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2011", Section 21, Paragraph 2 states that, 'bf the amount appropriated for LDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund for relief and recovery programs in order that situations and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, or complex emergencies, may be normalized as quickly as possible.";

WHEREAS, LGU Narvacan in its commitment to allevaiate the living conditions of the victims of this destructive typhoon and render assistance to those in need as a consequence of this calamity shall utilize the 30% Quick Response Fund as provided under RA 10121;

NOW THEREFORE, on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** authorizing the use of the 30% Quick Response Fund from the Local Disaster Risk Reduction Management Fund for Relief Expenses and other Recovery Operation Incidental Expenses related to the Calamity (typhoon 'Ompong');

RESOLVED FURTHER, that a copy of this Resolution be forwarded to all concerned for their information and reference.
