RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR TO OPEN A NEW ACCOUNT FOR THE MANDATORY IMPLEMENTATION OF AUTO CREDIT PAYMENT SCHEME FOR PROFESSIONAL FEE OF THE PHILIPPINE HEALTH INSURANCE CORPORATION WITH THE LAND BANK OF THE PHILIPPINES—NARVACAN BRANCH AND EMPOWERING THE HONORABLE ZURIEL S. ZARAGOZA, MUNICIPAL MAYOR AND MRS. GEMMA A. CABANTING, MUNICIPAL TREASURER—OIC AS OFFICIAL SIGNATORIES

WHEREAS, pursuant to PhilHealth Circular 2017-0020 on the nationwide implementation of Auto Credit Payment Scheme (ACPS) – Professional Fee (PF), all accredited Health Care Institutions (HCIs) are required to be ACPS compliant for purposes of claims reimbursements;

WHEREAS, Philhealth Advisory No. 2017-0050 mandates the registration of Bank Accounts for the Mandatory Implementation of Auto Credit Payment Scheme (ACPS) – Professional Fee (PF) and further states that All accredited Health Care Institutions (HCI) should be ACPS-Compliant by November 29, 2017 otherwise reimbursements shall be put on hold and checks shall not be issued to HCIs that do not comply with the ACPS requirements;

WHEREAS, it is necessary to open a new account with the Land Bank of the Philippines—Narvacan Branch for which the Auto-Credit Payment Scheme – Professional Fee (PF) shall be credited;

WHEREAS, the Local Chief Executive and the Municipal Treasurer in the persons of, Mayor **Zuriel S. Zaragoza**, and **Mrs. Gemma A. Cabanting**, Municipal Treasurer—OIC shall be the official signatories in all financial transactions concerning the Implementation of Auto-Credit Payment Scheme (ACPS) – Professional Fee (PF) entered into by the Local Government Unit of Narvacan, Ilocos Sur and the Land Bank of the Philippines – Narvacan Branch;



RESOLVED FURTHER that this Resolution be effective immediately upon approval by the Sangguniang Bayan;


RESOLVED FINALLY that copies of this Resolution be forwarded to all agencies and parties concerned for their information and appropriate action.






