A RESOLUTION EXPRESSING OUR FULL SUPPORT FOR HOUSE BILL NO. 6276 ENTITLED "AN ACT ENSURING THE CONTINUOUS AND UNINTERRUPTED TRANSMISSION AND DISTRIBUTION OF ELECTRICITY, THE PROTECTION OF THE INTEGRITY AND RELIABILITY OF THE TRANSMISSION AND DISTRIBUTION SYSTEMS, AND THE PROMOTION OF PUBLIC SAFETY, AND PROVIDING PENALTIES IN VIOLATION THEREOF"

WHEREAS, the lower house has already approved House Bill No. 6276, also known as "The Anti-Power Line Disturbance Act";

WHEREAS, the Municipal Government of Narvacan joins the Ilocos Sur Electric Cooperative, Inc. (ISECO) in its campaign to prevent obstructions and illegal connections along power lines, to ensure the continuous flow of electricity in households, commercial centers and industries in the country;

WHEREAS, House Bill No. 6276 will facilitate the trimming, pruning and cutting or clearing of tall growing plants and trees, as well as the removal of obstructions and hazardous improvements within the right-of-way of electric power lines;

NOW THEREFORE, for and in consideration of the foregoing premises, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan of Narvacan, Ilocos Sur to express our full support for House Bill No. 6276 entitled "An Act Ensuring the Continuous and Uninterrupted Transmission and Distribution of Electricity, the Protection of the Integrity and Reliability of the Transmission and Distribution Systems, and the Promotion of Public Safety, and Providing Penalties in Violation Thereof";

RESOLVED FURTHER that copies of this Resolution shall be furnished to the ISECO and the Office of the Senate through the Senate Committee on Energy, for their guidance and information.
