
RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR FOR REGIONAL FIELD OFFICE I HON. MARCELO NICOMEDES J. CASTILLO, FOR THE IMPLEMENTATION OF THE PROTECTIVE SERVICES PROGRAM OF THE DSWD

WHEREAS, Republic Act No. 7160, or the Local Government Code of 1991 particularly, Article 87 (b) (vi) (Powers, Duties & Functions of the Municipal Mayor) mandates that *"For effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants, the Municipal Mayor shall: Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance"*;

WHEREAS, the Department of Social Welfare and Development, as a leader in social protection, is mandated to work towards the achievement of improved capacities and opportunities of the poor, vulnerable and disadvantaged individuals, families and communities, to enable them to improve their quality of life. On this, the Department continuously implements social welfare and development (SWD), Social Protection (SP) and ante-poverty programs and projects in partnership with various intermediaries;

WHEREAS, the Protective Services Program (PSP) is part of the Department of Social Welfare and Development's protective services for the poor, marginalized and vulnerable/disadvantaged individuals. The Protective Services Program has been implemented by the Department of Social Welfare and Development for decades, as part of its technical assistance and resource augmentation support to Local Government Units and partners;
