RESOLUTION ADOPTING ADMINISTRATIVE ORDER No. 2018-0001: REVISED RULES AND REGULATIONS GOVERNING THE LICENSURE OF LAND AMBULANCES AND AMBULANCE SERVICE PROVIDERS

WHEREAS, LGU-Narvacan espouses the right of patients to safe and quality health care;

WHEREAS, the Sangguniang Bayan of Narvacan concurs that regulation shall be laid down to ensure that health facilities and services shall comply with the quality standards that will not put patients' lives at risk;

WHEREAS, the issuance of Administrative Order No. 2018-0001: 'Revised Rules and Regulations Governing the Licensure of Land Ambulances and Ambulance Service Providers' establishing the mandatory minimum standards and requirements for the licensure of ambulances has been declared;

WHEREAS, the Health Facilities and Services Regulatory Bureau (HFSRB) of the Department of Health set the basic requirements as well as the minimum structural inputs in relation to ambulance design, physical facilities, manpower, and equipment for the operation of ambulance and ambulance service providers;

WHEREAS, pursuant to the said Administrative Order, all government and private ambulance and ambulance service providers are now required to secure a License to Operate (LTO) from the Department of Health;

WHEREAS, the adoption of the abovementioned Administrative order will ensure the safety and protection of all patients under the care of ambulance service providers whether government operated or privately owned;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt **Administrative Order No. 2018-0001: Revised Rules And Regulations Governing The Licensure Of Land Ambulances And Ambulance Service Providers**;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Health Facilities and Services Regulatory Bureau (HFSRB) of the Department of Health and all parties concerned for their information and appropriate action.






