RESOLUTION GRANTING THE LOCAL CHIEF EXECUTIVE HON. ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE I (DA-RFO1) REPRESENTED BY REGIONAL EXECUTIVE DIRECTOR, LUCRECIO R. ALVIAR, JR. CESO III AND REGIONAL AGRICULTURE AND FISHERY COUNCIL (AFC) REPRESENTED BY THE REGIONAL AGRICULTURE AND FISHERY COUNCIL CHAIRMAN, MR. VINCENT A. ADORNA FOR THE IMPLEMENTATION OF THE SMALL SCALE IRRIGATION PROJECTS (SSIPs)

WHEREAS, the Department of Agriculture (DA) promotes agricultural development through a bottom-up self-reliant farm systems approach that will emphasize social justice, equity, productivity, and sustainability in the use of agricultural resources;

WHEREAS, the Local Government Code of 1991 allows the national agency to complement national funded projects, facilities, programs, and services jointly or with the assistance of the Local Government Units (LGUs);

WHEREAS, cognizant of the Agriculture and Fishery Council's (AFC's) potential as partners in development providing private sector views and inputs, the Secretary of the Department of Agriculture (DA) issued Special Order No. 542, Series of 2007 authorizing the "AFC" to monitor and validate DA programs and projects;

WHEREAS, the construction of **Small Scale Irrigation Projects (SSIPs)** will surely build up agricultural development and increase production;

WHEREAS, identified as vital project for agricultural development and production under the SSIPs are the following: **Rehabilitation of Culebbeng Diversion Dam** located at Brgy. Marozo, Narvacan, Ilocos Sur, **Rehabilitation of Casilagan Diversion Dam** located at Brgy. Casilagan, Narvacan, Ilocos Sur, **Rehabilitation of Marozo Diversion Dam** located at Marozo, Narvacan, Ilocos Sur, **Rehabilitation of Margaay Diversion Dam** located at Margaay, Narvacan, Ilocos Sur, **Rehabilitation**

of Abuor Diversion Dam located at Abuor, Narvacan, Ilocos Sur and **Improvement of Bulbulala Diversion Dam** located at Brgy. Quinarayan, Narvacan, Ilocos Sur ;




