RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ZURIEL S. ZARAGOZA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE PROVISION OF SEED CAPITAL FOR THE PURCHASE OF BAKING EQUIPMENT AND MATERIALS UNDER THE DOLE LIVELIHOOD (KABUHAYAN) PROGRAM IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Department of Labor and Employment (DOLE) is in the process of implementing the Grassroots Participatory Budgeting Process (GPBP) projects, and DOLE Integrated Livelihood and Emergency Program in the Municipality of Narvacan, Ilocos Sur;

WHEREAS, the Grassroots Participatory Budgeting Process (GPBP) is an approach in carrying out the priority poverty reduction projects as identified in the Local Poverty Reduction Action Plan;

WHEREAS, the DOLE Integrated Livelihood Program (DILP)/DOLE Integrated Livelihood and Employment Program (DILEEP) is a livelihood formation strategy that is intended to improve the socio-economic well-being of marginalized and unprotected worker;

WHEREAS, this body acknowledges the role of the DOLE in providing assistance in pursuit of attaining the Philippine Development Plan's goal at the municipal level;

WHEREAS, the Municipal Government is enthusiastic and capable to provide the twenty percent (20%) equity of the total project cost being required by the DOLE;




