A RESOLUTION REQUESTING THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) TO CONDUCT AN INVESTIGATION OF THE ABANDONED SPEEDBOAT AT BRGY. TUROD, NARVACAN, ILOCOS SUR ON FEBRUARY 9, 2018 WHICH IS NOW UNDER THE CUSTODY OF THE ILOCOS SUR POLICE PROVINCIAL OFFICE (ISPPO) – LOGISTIC BRANCH

WHEREAS, the Municipal Government of Narvacan fully supports the all-out war against drugs throughout the country under the present administration of President Rodrigo Duterte;

WHEREAS, there have been reports of an abandoned speedboat along the seashore at Brgy. Turod, Narvacan, Ilocos Sur on February 9, 2018, which is suspected of being used in the transport of illegal drugs and/or other illegal drug activities;

WHEREAS, an on-the-spot investigation was conducted by the PNP-Narvacan Municipal Police Station and CIDG-Ilocos Sur, with the coordination of concerned barangay officials;


WHEREAS, the abandoned speedboat and recovered evidence have now been turned over to, and are now under the custody of the Ilocos Sur Police Provincial Office (ISPPO) – Logistic Branch for further investigation;

NOW THEREFORE for and in consideration of the foregoing premises, be it RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan of Narvacan, Ilocos Sur to request the Philippine Drug Enforcement Agency (PDEA) to conduct an investigation of the abandoned speedboat at Brgy. Turod, Narvacan, Ilocos Sur on February 9, 2018, which is now under the custody of the Ilocos Sur Police Provincial Office (ISPPO) – Logistic Branch;

RESOLVED FURTHER that copies of this Resolution be forwarded to the Philippine National Police (PNP), the Department of the Interior and Local Government (DILG) and President Rodrigo Duterte.
