RESOLUTION EARNESTLY REQUESTING HONORABLE KRISTINE SINGSON MEEHAN, CONGRESSWOMAN OF THE SECOND DISTRICT OF ILOCOS SUR FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTEEN MILLION PESOS (P15M) FOR THE CONSTRUCTION OF A CONCRETE BRIDGE IN BARANGAY SAN PEDRO IN THIS MUNICIPALITY

WHEREAS, progress demands opportunities for growth and development, hence, the Municipal Government has placed as one of its development agenda the CONSTRUCTION OF CONCRETE BRIDGES in this municipality;

WHEREAS, this goal, however, is constrained by financial limitations as LGU Narvacan depends on financial assistance from the congressional, provincial and national government to fund its development projects;

WHEREAS, at present, the Municipal Administration earnestly needs development funds to meet the urgency for the CONSTRUCTION OF A CONCRETE BRIDGE in Barangay San Pedro to replace the Barangay's temporary collapsed bailey bridge;

WHEREAS, when fully realized, this growing fishing village will be provided with a better, faster and safer means of transporting their fresh catch of fish for the day and other seafood merchandises including their agricultural produce to the market, as well as promoting inter-trade relations with neighboring barangays, thereby enhancing economic growth and development;

WHEREAS, the concrete bridge will be permanent, strong, reliable and not prone to collapse specially during storm surges and typhoons and will eliminate the inconvenience and difficult predicament that the residents of this barangay experience with just a temporary weak bailey bridge to depend on;
