



RESOLUTION AMENDING SECTION 16 (6) (7) AND SECTION 17 (6) (7) OF THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR FOR 2019 – 2022 AND THE CREATION OF THE COMMITTEE ON LABOR AND EMPLOYMENT AND CIVIL SERVICE

WHEREAS, pursuant to Sec. 50 of the Local Government Code of 1991, the Sangguniang Bayan of Narvacan, Ilocos Sur approved its own set of Revised Internal Rules of Procedure (IRP) for 2019-2022 on July 1, 2019,

WHEREAS, Section 16 of the approved revised IRP enumerated the standing committees and identified its elected Chairmen and Members;

WHEREAS, Section 16 (6) provided for the Committee on Social Services (PWD, Gender and Development and Family Affairs and Section 16 (7) provided for the Committee on Senior Citizens Affairs;

WHEREAS, the Committee on Rules, Privileges, Good Governance, Public Ethics, Ordinances and Legal Matters decided to include under Section 16 (6) the Lesbian, Gay, Bisexual, Transgender (LGBT) Community and under Section 16 (7) the Overseas Filipino Workers (OFW) and providing under Section 17 (6) (7) for their jurisdiction and function;

WHEREAS, the Committee on Rules further determined for the creation of the Committee on Labor and Employment and Civil Service;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to amend Section 16 (6) (7) and Section 17 (6) (7) of the Revised Internal Rules of Procedure of the Sangguniang Bayan of Narvacan, Ilocos Sur and to include Section 16 (18), to wit:

Section 16 (7). Committee on Senior Citizens and Overseas Filipino Workers (OFWs)





A RESOLUTION MANDATING ATTY. PABLO F. SANIDAD II AS REPRESENTATIVE OF MAYOR LUIS "CHAVIT" SINGSON TO THE PROTECTED AREA MANAGEMENT BOARD (PAMB) OF NORTHERN LUZON HEROES HILL NATIONAL PARK (NLHHNP) LOCATED IN NARVACAN, ILOCOS SUR

WHEREAS, the Northern Luzon Heroes Hill National Park (NLHHNP) covering an area of 1, 316 hectare is within the territorial jurisdiction of Narvacan, Ilocos Sur particularly in Barangay Lungog, Camarao and Sulvec;

WHEREAS, the establishment of Northern Luzon Heroes Hill National Park (NLHHNP) as initial component of Republic Act 7586 or the National Integrated Protected Areas Systems Acts of 1992 as amended by Republic Act 11038 or the Expanded National Integrated Protected Areas Systems or ENIPAS Act of 2018 is pursuant to Proclamation No. 132 dated July 9, 1963;

WHEREAS, Section 11 of ENIPAS Act provides that a PAMB shall be created for each of the Protected Areas designated as initial component, established by presidential proclamation, and declared by law;

WHEREAS, members of the Board shall have the Mayor/s of the city/cities or municipality/municipalities where the protected area is located or their duly designated representative/s;

WHEREAS, Ex-officio members or members of the PAMB by virtue of their elective or appointive government positions shall serve for the duration of their respective terms of office in their respective elective or appointive positions;

NOW THEREFORE, on motion duly seconded;

RESOLVED AS IT IS HEREBY RESOLVED, to Authorize Atty. Pablo F. Sanidad II as Representative of Mayor Luis "Chavit" Singson to the Protected Area Management Board (PAMB) of Northern Luzon Heroes Hill National Park (NLHHNP);

RESOLVED FINALLY, that a copy of this resolution be forwarded to the Office of the Chairman of PAMB and the Regional Executive Director of DENR-R1 through Community Environment and Natural Resources Office of Northern Ilocos Sur (CENRO- Northern Ilocos Sur) and to the Office of the DENR Secretary for his appointment;
