





RESOLUTION MANDATING THE CREATION OF THE MUNICIPAL TECHNICAL WORKING GROUP (TWG) FOR THE UPDATING OF PROTECTED AREA MANAGEMENT PLAN OF BIGBIGA PROTECTED LANDSCAPE LOCATED IN NARVACAN, ILOCOS SUR

WHEREAS, the Bigbiga Protected Landscape covering an area of 142.87 ha within the territorial jurisdiction of Narvacan, Ilocos Sur;

WHEREAS, the establishment of Bigbiga Protected Landscape is pursuant to Republic Act 11038 or the Expanded National Integrated Protected Areas System or ENIPAS Act of 2018;

WHEREAS, Section 9 of ENIPAS Act provides the legislation of Bigbiga Protected Landscape requires the formulation of Protected Area Management Plan (PAMP) which serves as basic long term framework plan in protected area management and guide in the preparation of its annual operation, plan and budget;

WHEREAS, The PAMP of Bigbiga Protected Landscape shall harmonize with the Comprehensive Land Use Plans (CLUP) of the municipality required under Republic Act 7160 or the Local Government Code of 1991;

WHEREAS, this Technical Working Group shall work closely with authorized DENR personnel and staff until the finalization of the PAMP Bigbiga Protected Landscape;


