RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR LUIS "CHAVIT" C. SINGSON TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) FOR THE ESTABLISHMENT OF A MIGRANT DESK IN THIS MUNICIPALITY

WHEREAS, the Overseas Workers Welfare Administration (OWWA) continues to develop and implement responsive programs and services towards the protection of the interest and promotion of the welfare of its member Overseas Filipino Workers (OFWs) and their families;

WHEREAS, the OWWA recognizes the critical role of the Local Government Units and various sectors in pursuing and bringing its programs and services closer to its OFW clientele and their families;

WHEREAS, the Municipality of Narvacan identifies the responsibility to provide immediate and appropriate assistance to OFWs and their families by way of establishing a Migrant Desk;

WHEREAS, this Resolution authorizes the Municipal Mayor Luis "Chavit" C. Singson to enter into a MOA with the OWWA which stipulates, among other things, that the OWWA and the Municipality of Narvacan shall meet regularly to coordinate and assess the effective implementation of the Agreement and discuss and address issues relative to the OFWs and their families;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Luis "Chavit" C. Singson to enter into a Memorandum of Agreement (MOA) with the Overseas Workers Welfare Administration (OWWA) for the establishment of a Migrant Desk in this municipality;

RESOLVED FURTHER that a copy of this Resolution be forwarded to the Overseas Workers Welfare Administration (OWWA) represented by its Administrator, **HON. CARMELITA S. DIMZON, DPA**, to manifest adherence of the Municipality of Narvacan, to the Memorandum of Agreement (MOA).
