RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOCOS SUR DISTRICT HOSPITAL REPRESENTED BY DR. RONALD REMEGIO TOBIAS FOR THE VOLUNTARY BLOOD DONATION RECRUITMENT

WHEREAS, LGU Narvacan and the Narvacan Ilocos Sur District Hospital envisions institutionalizing the Department of Health's voluntary blood donation program by setting up voluntary blood donation active in the schools, churches, government and non-government organizations;

WHEREAS, the dependence on the paid blood donation system through commercial blood bank esxposes the Narvacaneans to such dreadful diseases such as Malaria, Hepatities B and C and other transmissible diseases;

WHEREAS, LGU Narvacan and the Narvcan Ilocos Sur District Hospital agree that collaboration between government and non-government institutions are potential sources of blood donors and answers the problem on insufficient supply of blood needed by hospitals for transfusion to patients;

WHEREAS, LGU Narvacan and the Narvacan Ilocos Sur District Hospital are confident that this voluntary Blood Donation Recruitment Activity will benefit all Narvacaneans and the promotion and awareness of the campaign will give Narvacaneans the chance to be potential donors;

WHEREAS, LGU Narvacan and the Narvacan Ilocos Sur District Hospital decided to enter into a Memorandum of Agreement to spearhead this program;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to authorized the Honorable Luis "Chavit C. Singson, Municipal Mayor, Narvacan, Ilocos Sur To Enter Into A Memorandum Of Agreement (MOA) With The Ilocos Sur District Hospital Represented By Dr. Ronald Remegio Tobias For The Voluntary Blood Donation Recruitment;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement entered into by and between:

The MUNICIPALITY OF NARVACAN, a local government unit duly organized and existing under the laws of the Philippines, with address at NARVACAN, ILOCOS SUR herein referred to as MUNICIPALITY and represented by its Municipal Mayor, HON. LUIS "CHAVIT" SINGSON hereafter known as FIRST PARTY.

-and-

ILOCOS SUR DISTRICT HOSPITAL- NARVACAN with principal office address at Paratong, Narvacan, Ilocos Sur represented by **DR. RONALD REMEGIO TOBIAS** hereinafter known to as **SECOND PARTY**.

WITNESSETH:

Whereas, both parties are cognizant:

- A. That dependence on the paid blood donation system through commercial blood bank has unduly exposed the Filipino people to such dreaded diseases such as Malaria, Hepatitis B and C and their blood transmissible diseases;
- B. That one of the best ways to prevent further contagion of the above blood transmissible disease is through voluntary blood donation.

WHEREAS both PARTIES envision helping the Department of Health institutionalize voluntary blood donation in the country by setting up voluntary blood donation active in the schools, churches, government and non-government organizations;

WHEREAS both PARTIES believe that collaboration and cooperation between the government and non-government institutions are potential sources of blood and active dissemination of the benefits of voluntary blood donations;

WHEREAS both PARTIES believe that the country's colleges, universities, business establishments and civic organizations are potential sources of blood and active disseminators of the benefit of voluntary blood donation:

NOW THEREFORE, in consideration of the premises and mutual promises and agreement contained herein, the PARTIES hereto, intending to be legally bound to one another, hereby agree as follows:

- 1. The project subject to this Memorandum of Agreement shall be known as the Voluntary Blood Donation Recruitment at **MUNICIPALITY OF NARVACAN** locales.
- 2. The parties will hold bloodletting activities on such date, time and place agreed by them.
- 3. All supplies and technical equipment needed for the said bloodletting will be provided by the **SECOND PARTY.**

- 4. The promotion and awareness campaign prior to the scheduled date bloodletting will be arranged and done through joint efforts by two parties. All promotional material will be supplied by **SECOND PARTY**.
- 5. All potential donors will be physically examined free of charge and will have hemoglobin determination and blood typing also free of charge prior to donation. Free screening test for Hepatitis B and C. Malaria, Syphilis and HIV will be done on all units of blood collected. In the event that a potential donor is found to be a reactive for any of the above, **SECOND PARTY** shall provide the individual free counselling on medical health issue that need to be addressed and results are strictly confidential.
- 6. The **FIRST PARTY** shall get 50% of the total blood units collected as needed within twelve-month period. The blood will be free of charge and will be available to them upon endorsement of the HEALTH SERVICE COORDINATOR of FIRST PARTY. Stock unused within twelve (12) months period shall be cumulative and added to the available units for succeeding year.
- 7. A report of the blood stock level will be sent to the office of the **FIRST PARTY** on a monthly basis to include the number of units drawn;

8. FINALLY, herein parties thus hereby mutually agreed to	upon that this agreement s	hall be binding and
