RESOLUTION NO. 11-A-SS

Series of 2019

RESOLUTION DECLARING THE NARVACAN WATCH TOWER AT SULVEC A "MUNICIPAL CULTURAL PROPERTY"

WHEREAS, pursuant to its constitutional mandate expressed in Secs. 14,15,16 and 17, Art. XIV of the 1967 Constitution, it is the declared policy of government, under Republic Act. No. 10066, the "National Cultural Heritage Act of 2009" to "protect, preserve, conserve and promote the nation's cultural heritage, its property and histories, and the ethnicity of local communications";

WHEREAS, the NARVACAN WATCH TOWER located at Sulvec, Narvacan, Ilocos Sur, which dates back to the Spanish times, is portrayed in the Municipal Seal of the town and undoubtedly a structure of historical and cultural significance, not only to the town of Narvacan and the Province of Ilocos Sur, but also to the entire country, and falls under the category of "Built Heritage" under R.A. 10066;

WHEREAS, the National Commission for Culture and Arts, established by the National Cultural Heritage Act of 2009 (R.A. No. 10066) has established a registry of all cultural property of the country deemed important to our cultural heritage;

WHEREAS, due to its historic and cultural significance, the NARVACAN WATCH TOWER is listed in the said registry of cultural properties;

WHEREAS, in order to underscore the historic and cultural significance of the NARVACAN WATCH TOWER and to show the value, regard, respect and attachment that the town of Narvacan and its people, have for the said property, there is need to declare it as a Municipal Cultural Property and thus bring it under the protection of the law and government agencies involved in the identification, protection and preservation of Philippine cultural properties;
