RESOLUTION EARNESTLY REQUESTING TWO BRAND NEW FIRE TRUCKS FROM THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE OFFICIAL USE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration is sincerely committed to pursue a vision of a peaceful and progressive community;

WHEREAS, the Municipal Administration deems it necessary to enact measures to ensure the safety and welfare of the people;

WHEREAS, one of these measures is to promote efficient fire prevention service to the people of Narvacan;

WHEREAS, the fire truck being used by the Municipality is 39 years old, hence, not capable to meet the demands of ensuring fire prevention/protection and rescue operations in case of emergencies;

WHEREAS, it is paramount for the LGU to acquire 2(two) brand new fire trucks that shall gear up our plans of modernizing our fire prevention campaigns and rescue operations for our fast-growing community;

WHEREAS, the 2(two) new fire trucks shall competently contribute in the fast and effective response to fire and other emergencies not only in the locality but in the neighboring towns as well;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session duly assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to request a brand new fire truck from the Department of the Interior and Local Government (DILG) for the official use of the Municipality of Narvacan, Ilocos Sur;
