#### **RESOLUTION NO. 04-SS** Series of 2019

RESOLUTION EARNESTLY REQUESTING PRESIDENT RODRIGO ROA DUTERTE, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH SECRETARY EDUARDO M. AÑO, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) **EMERGENCY AND DISASTER** TO PROVIDE VEHICLES FOR THE PROTECTION AND WELFARE OF THE **NARVACANEANS**
