RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR OR ATTY. PABLO F. SANIDAD II, MUNICIPAL ADMINISTRATOR AND MRS. GEMMA A. CABANTING, MUNICIPAL TREASURER-OIC AS OFFICIAL SIGNATORIES OF ALL MUNICIPAL ACCOUNTS WITH THE LAND BANK OF THE PHILIPPINES

WHEREAS, the Municipality of Narvacan has existing accounts with the Land Bank of the Philippines – Narvacan Branch;

WHEREAS, the Municipality has a newly-installed administration, and by law, (RA 7160 The Local Government Code) the Members of the Sangguniang Bayan is dictated upon to authorize official signatories of all municipal accounts with the Land Bank of the Philippines;
