A RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR TO TERMINATE THE TIME DEPOSIT ACCOUNT FOR RA 7171 AND RA 8240 AMOUNTING TO PHP 300,000,000.00 PESOS PLUS INTEREST IN THE LAND BANK OF THE PHILIPPINES

**WHEREAS**, the Land Bank of the Philippines has been designated as an official depository with full authority to maintain deposits of the Government, its branches, subdivisions and instrumentalities;

**WHEREAS**, the Municipal share of the Municipality of Narvacan from the collection of excise tax from Virginia-type cigarettes under RA 7171 and Burley and native tobacco under RA 8240 has been released for implementation and utilization consistent with the guidelines set forth by the Department of Budget and Management for 2017 and 2018;

**WHEREAS,** a portion of the funds of RA 7171 and RA 8240 were programmed for implementation and utilization after the first semester of CY 2018;

**WHEREAS,** the funds subject for implementation and utilization amounting to Php 300,000,000.00 Pesos has been placed on a high yield time deposit account generating revenues for the Municipality for further appropriation upon generation of the interest income;

**WHEREAS**, the above mentioned amount plus interest needs to be transferred to the current account under the general fund of the Municipality in order to carry out all the remaining identified projects subject for implementation and utilization under RA 7171 and RA 8240 for year 2017 and 2018;

**WHEREAS**, the Sangguniang Bayan is Empowering the Municipal Mayor Zuriel S. Zaragoza and the Acting Municipal Treasurer Gemma A. Cabanting as Official Signatories for the termination and transfer of the aforementioned time deposit account;

**NOW THEREFORE,** for and in consideration of the foregoing premises, be it **RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan of Narvacan, Ilocos Sur to Authorize The Local Government Unit Of Narvacan, Ilocos Sur To Terminate The Time Deposit Account For RA 7171 And RA 8240 Amounting To Php 300,000,000.00 Pesos Plus Interest In The Land Bank Of The Philippines
