A RESOLUTION AUTHORIZING HON. LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR OF NARVACAN, ILOCOS SUR TO ENTER INTO A MEMORANDUM OF AGREEMENT, FOR AND IN BEHALF OF THE MUNICIPALITY WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT FOR THE IMPLEMENTATION OF THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM IN THE MUNICIPALITY

WHEREAS, it is the national government's policy to implement poverty alleviation project in all regions;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

The OVERSEAS WORKERS WELFARE ADMINISTRATION an attached agency of the Department of Labor and Employment (DOLE), with principal office at OWWADEC Building 7th Street Corner F.B. Harrison Street, Pasay City, represented by its Administrator, HON. CARMELITA S. DIMZON, DPA, and hereinafter referred to as "OWWA"

-and-

The Narvacan, Ilocos Sur, a Local Government Unit with office address at Narvacan, Ilocos Sur, and herein represented by HON. LUIS "CHAVIT" C. SINGSON, Municipal Mayor and hereinafter referred to as NARVACAN, ILOCOS SUR

- WITNESSETH -

WHEREAS, the OWWA is a lead membership welfare institution that serves the interest and welfare of member Overseas Filipino Workers (OFW) and their families;

WHEREAS, the OWWA develops and implements responsive programs and services towards the protection of the interest and promotion of the welfare of its member OFWs and their families;

WHEREAS, the OWWA recognizes the critical role of the Local Government Units and the participation of various sectors in pursuing and bringing its programs and services closer to its OFW clienteles and their families;

WHEREAS, the municipality of Narvacan, Ilocos Sur recognizes the responsibility to provide immediate and appropriate assistance to OFWs and their families;

NOW THEREFORE, in the light of the forgoing premises, the PARTIES now enter into this Agreement and commit to do the following in line with the above mentioned project sought to be implemented.

Section 1. On the part of the OWWA

- a. To provide an orientation to the assigned LGU personnel to the OFW Migrant Desk regarding the programs and services of the agency, the procedure and processes in availing of the programs and other guidelines that maybe deem necessary for the swift delivery of its program and services;
- b. To conduct regular consultation and monitoring thru its Family Welfare Officer to the assigned LGU personnel for the immediate clarification and resolution on issues and concerns raised by the clients; and

Section 2. On the part of the Municipality of Narvacan, Ilocos Sur:

- a. Shall assign a Staff/PESO staff to take charge of the OFW Migrant Desk, additional expenses incurred subject to the discretion and approval of the Mayor;
- b. Shall coordinate with OWWA as often as necessary in the provision of the programs and services of the agency;
- c. Shall provide appropriate assistance to the OFWs and their families thru its available programs and services aside from assistance coming from OWWA;
- d. Shall refer OFWs and their families directly to OWWA for programs and services availments including welfare cases.

Section 3. Joint Undertaking of OWWA and the Municipality of Narvacan, Ilocos Sur

To meet regularly to coordinate and assess the effective implementation of this Agreement and discuss and address such relevant issues thereto.

Section 4. EFFECTIVITY

This MEMORANDUM OF AGREEMENT shall be immediately effective upon the signing hereof.
