RESOLUTION NO. 64-SS
Series of 2019

A RESOLUTION REVERTING/REALIGNING THE AMOUNT OF EIGHT HUNDRED FIFTY THOUSAND SEVEN HUNDRED FORTY PESOS (PHP 850,740.00) FROM THE APPROPRIATED VACANT POSITIONS FROM JULY, 2019 TO DECEMBER, 2019 IN THIS MUNICIPALITY

WHEREAS, under Section (4)(iv) of Congress Joint Resolution (JR) No. 4 dated 17 June 2009, the President, upon recommendation of the Department of Budget and Management (DBM), is authorized the grant of a) incentives to reward an employee's loyalty to government service and contributions to the agency's continuing viable existence; b) incentives as rewards for exceeding agency financial and operational performance targets to motivate employee efforts toward higher productivity, and c) other existing benefits to be categorized by the DBM as incentives;

WHEREAS, with the belief that government employees deserve to be rewarded to recognize their collective and unceasing participation in and invaluable contribution to the Administration's continuing efforts toward the establishment of streamline government processes and more responsive delivery of public services, the President of the Republic of the Philippines, His Excellency, RODRIGO ROA DUTERTE, passed ADMINISTRATIVE ORDER NO. 19, "AUTHORIZING THE GRANT OF **SERVICE RECOGNITION INCENTIVE (SRI)** TO GOVERNMENT EMPLOYEES FOR FISCAL YEAR (FY) 2019;

WHEREAS, the conditions set forth to the granting of the SRI under Section 2 of Administrative Order 19 decrees the following: a) the civilian personnel are occupying regular, contractual or casual positions; b) the personnel are still in government service as of 30 November 2019; c) the personnel have rendered at least four (4) months of service as of 30 November 2019; d) employees who have rendered less than four (4) months of service as of 30 November 2019 shall be entitled to pro-rated share of the SRI;

WHEREAS, Section 6 of Administrative Order No. 19 provides that, "the grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective Sanggunian depending on the LGU's financial capability, subject to the PS Limitation in LGU budgets under RA No. 7160 or the Local Government Code of 1991 and the conditions set in Section 2 hereof, at a uniform rate not exceeding Ten Thousand Pesos (Php 10,000.00), chargeable against their respective FY 2019 local government funds";

WHEREAS, the members of the sanggunian are further enjoined to exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public.

WHEREAS, the reversion/realignment of account from the appropriated vacant position from July to December 2019 for Municipal Department Head, PESO Manager and Municipal Planning Development Head, with the total amount of eight hundred fifty thousand seven hundred forty pesos (Php 850,740.00), will suffice the needed funding for the availment of the SRI;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to revert/realign the amount of eight hundred fifty thousand seven hundred forty pesos (php 850,740.00) from the appropriated vacant positions from July, 2019 to December, 2019 in this municipality;
