RESOLUTION AUTHORIZING THE HONORABLE LUIS 'CHAVIT' C. SINGSON, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE MUNICIPALITY OF NARVACAN WITH THE WIRELESS ACCESS FOR HEALTH INITIATIVE, INC. (WAH-NGO) FOR THE ADOPTION AND INSTALLATION OF THE "WAH DIGITAL HEALTH PLATFORM" SOFTWARE

WHEREAS, Wireless Access for Health Initiative, Inc. (WAH-NGO) is a partner to the Philippine Health Insurance Corporation or PHILHEALTH and the Department of Health or DOH in implementing Republic Act 11223 otherwise known as the Universal Health Care (UHC) Law by providing quality digital health solutions to Health Care Institutions (HCIs) allowing these to comply with PHILHEALTH benefits claims transactions like the Electronic Claims (eClaims) and the Primary Care Benefit Package (PCB) and the DOH's electronic health reporting programs like the Field Health Service Information System (FHSIS), Integrated Tuberculosis Information System, National Anti-Rabies Information System, among others;

WHEREAS, WAH-NGO is a third-party service provider duly authorized, accredited and licensed by PHILHEALTH to engage with HCIs for the purpose of providing them access to PHILHEALTH's claims and reimbursements web-service and utility framework through the WAH-NGO's "Digital Health Platform" Software;

WHEREAS, WAH-NGO and the Health Care Institution Partner or HCIP, as partners of PHILHEALTH and the DOH have agreed in a previous Memorandum of Agreement or MOA to comply with various legal pronouncements governing the implementation of the Philippine Health Information Exchange or PHIE and the validation of Electronic Medical/Health Recording Systems (EMR/EHR) such as DOH Administrative Orders (AO) 2011-010 and 2017-0024; PHILHEALTH Advisories 11-01-2015, 2016-0040, and 2016-0041; Circulars 2016-13 and 2017-0030; and DOH, PHILHEALTH, and Department of Science and Technology (DOST) Joint AO 2016-001, 2016-002 and 2017-0027;

WHEREAS, HCI PARTNER, in adherence to these DOH and PHILHEALTH regulations to connect to the PHIE (and PHILHEALTH Server) must send QUALITY electronic patient and health data for program reporting (DOH FHSIS, etc.) and claims reimbursements (PHILHEALTH eClaims and PCB) and therefore decided to partner with and engage the expertise and services of the WAH-NGO by adopting and installing in its health facility the "WAH Digital Health Platform" Software;
