**WHEREAS**, GMA TV 48/5 ILOCOS accepted the Contract Agreement and concurred to furnish the Local Government Unit of Narvacan television broadcasting facilities subject to the terms and conditions of the Contract Agreement which provides, among others, that the Municipality of Narvacan shall pay the said television station a total cost of ONE MILLION TWO HUNDRED NINETY NINE THOUSAND AND TWO HUNDRED PESOS (Php 1,299,200.00);

**WHEREAS**, the amount of Php 1,299,200.00 shall be chargeable against the unutilized fund for programs/projects/activities of FY 2019 20% development fund realigned for funding of Tourism and Socio-Cultural Activities as recommended by the Municipal Development Council;
