**RESOLUTION AUTHORIZING ATTY. PABLO F. SANIDAD II, MUNICIPAL ADMINISTRATOR, NARVACAN, ILOCOS SUR TO ENTER INTO AND SIGN AN ENGAGEMENT AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF NARVACAN WITH THE SOUTH BORDER, REPRESENTED BY ITS BUSINESS MANAGER, MISS SHARON S. INDUCTIVO, FOR A 60-MINUTE MUSICAL PERFORMANCE FOR THE 443rd FOUNDING ANNIVERSARY CELEBRATION AND OTHER SOCIO-CULTURAL ACTIVITIES ON DECEMBER 8, 2019, 7:30 PM AT THE NARVACAN MALL GROUNDS**

**WHEREAS**, Southborder, represented by its Business Manager, Miss Sharon S. Inductivo, is a professional band who composes and performs R&B/Pop songs, ballads and other similar music pieces;

**WHEREAS**, the Municipality of Narvacan, represented by Atty. Pablo F. Sanidad II, Municipal Administrator, desires to engage the services of the Southborder, specifically, for a 60-minute musical performance for the Narvacan Town Fiesta on December 8, 2019, 7:30 PM at the Narvacan Mall Grounds;

**WHEREAS**, Southborder has accepted the engagement and has agreed to appear and perform in the Event subject to the terms and conditions of the Engagement Agreement which provides, among others, that the Municipality of Narvacan shall pay the Southborder a talent fee of Php 350,000.00 net of all taxes;

**WHEREAS**, the talent fee of Php 350,000.00 shall be chargeable against the unutilized fund for programs/projects/activities of FY 2019 20% development fund realigned for funding of Tourism and Socio-Cultural Activities as recommended by the Municipal Development Council;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Atty. Pablo F. Sanidad II, Municipal Administrator, Narvacan, Ilocos Sur, to enter into and sign an engagement agreement for and in behalf of the Municipality of Narvacan with the Southborder, represented by its Business Manager, Miss Sharon S. Inductivo, for a 60-minute musical performance for the 443rd founding anniversary celebration and other socio-cultural activities on December 8, 2019, 7:30 PM at the Narvacan Mall grounds;

**RESOLUTION AUTHORIZING THE UTILIZATION OF THE AMOUNT OF ONE HUNDRED THIRTEEN THOUSAND PESOS (PHP 113,000.00) CHARGEABLE AGAINST THE PEACE AND ORDER OPERATION EXPENSES/KATARUNGANG PAMBARANGAY AS APPROPRIATED UNDER THE GENERAL FUND, FOR THE MAINTENANCE OF PEACE AND ORDER DURING THE 443rd FOUNDING ANNIVERSARY CELEBRATION AND OTHER SOCIO-CULTURAL ACTIVITIES ON DECEMBER 8-15, 2019**

**WHEREAS**, on its 41<sup>st</sup> Regular Session, the Sangguniang Bayan passed and approved Resolution No. 40, Series of 2018 Resolution Adopting the Proposed 2019 Annual Municipal Budget;

**WHEREAS**, for public security and welfare and for a meaningful and successful Town Fiesta, peace and order need to be closely monitored and strictly maintained during the said dates;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the utilization of the amount of One Hundred Thirteen Thousand Pesos (Php 113,000.00) chargeable against the Peace and Order Operation Expenses/Katarungang Pambarangay as appropriated under the General Fund, for the maintenance of peace and order during the 443rd founding anniversary celebration and other socio-cultural activities on December 8-15, 2019;
