## **RESOLUTION NO. 161**

A RESOLUTION ADOPTING ADMINISTRATIVE ORDER NO. 38, DATED DECEMBER 28, 2020 OF PRESIDENT RODRIGO ROA DUTERTE "AUTHORIZING THE GRANT OF GRATUITY PAY FOR FISCAL YEAR 2020 TO CONTRACT OF SERVICE AND JOB ORDER WORKERS IN GOVERNMENT" IN THE MUNICIPALITY OF WORKERS IN GOVER NARVACAN, ILOCOS SUR

38, dated December 28, 2020 "Authorizing the Grant of Gratuity Pay for Fiscal Year 2020 to Contract of Service and Job Order Workers in Government"; WHEREAS, President Rodrigo Roa Duterte issued Administrative Order No.

**WHEREAS,** AO No. 38 authorizes the grant of a one-time Gratuity pay not exceeding Three Thousand Pesos (P3,000.00) to all workers whose services are engaged through Contract of Service (COS) and Job Order Order (JO) by:

a. National Government Agencies (NGAs);b. State Universities and Colleges (SUCs);

c. Government-Owned or Controlled Corporations (GOCCs);

d. Local Water Districts (LWDs); and e. Local Government Units (LGUs);

**WHEREAS,** COS and JO workers in the government are paid salaries/wages equivalent to the daily salaries/wages of comparable positions in government and a premium of up to 20% of such salary/wage. However, they do not enjoy benefits accorded to government employees such as the Personnel Economic Relief Allowance, Mid-Year and Year-End Bonuses and Performance -Based Bonus among others, considering employer-employee relationship with the government; that they have

**WHEREAS**, granting a year-end Gratuity Pay to COS and JO workers is a well-deserved recognition of their hard work in implementing programs, projects and activities, including those which are part of the emergency Covid -19 response efforts of the government;

**NOW THEREFORE**, in a special session assembled and on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt Administrative Order No. 38, dated December 28, 2020 of President Rodrigo Roa Duterte "Authorizing the Grant of Gratuity Pay for Fiscal Year 2020 to Contract of Service and Job Order Workers in Government";
