RESOLUTION ADOPTING ADMINISTRATIVE ORDER NO. 37, DATED DECEMBER 18, 2020 OF PRESIDENT RODRIGO ROA DUTERTE "AUTHORIZING THE GRANT OF SERVICE RECOGNITION INCENTIVE TO GOVERNMENT EMPLOYEES FOR FISCAL YEAR (FY) 2020" IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, President Rodrigo Roa Duterte issued Administrative Order No. 37, dated December 18, 2020 "Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2020";

WHEREAS, AO No. 37 authorizes the grant of a one-time Service Recognition Incentive (SRI) at a uniform rate not exceeding Ten Thousand Pesos (P10,000.00) for each of the following:

a. Employees in the Executive Department;

b. Employees in the Legislative and Judicial Departments and Other Offices Vested with Fiscal Autonomy;
c. Employees in Local Government Units (LGUs);

d. Employees in Local Water Districts (LWDs); and

e. Employees in Agencies Exempted from the Coverage of RA No. 6758, as amended;

WHEREAS, the grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunians depending on the LGU's financial capability, subject to the PS limitation in LGU budgets under RA No. 7160 or the Local Government Code of 1991, and chargeable against their respective FY 2020 local government funds;

WHEREAS, should the identified funding source prove insufficient to cover the full amount of the SRI, a lower but uniform amount shall be paid to all qualified employees of the LGU;

WHEREAS, in determining the amount of the SRI, the Sanggunian shall exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public;

NOW THEREFORE, in a special session assembled and on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt Administrative Order No. 37, dated December 18, 2020 of President Rodrigo Roa Duterte "Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2020";

RESOLVED FINALLY that copies of this Resolution be forwarded to all offices and agencies concerned for their information and appropriate actions.
