RESOLUTION NO. 152 Series of 2020

A RESOLUTION APPROVING BARANGAY RESOLUTION NO. 21, SERIES OF 2020 OF ESTANCIA, NARVACAN "A RESOLUTION APPROVING THE IMPLEMENTATION OF THE ALLOTED 10% YOUTH DEVELOPMENT FUND OF ONE HUNDRED FIFTY SEVEN THOUSAND TWO HUNDRED EIGHTY TWO PESOS ONLY FOR THE FOLLOWING YOUTH PROGRAMS, PROJECTS AND ACTIVITIES FOR THE BUDGET YEAR 2021"

WHEREAS, submitted to the Sangguniang Bayan of Narvacan for legislative review and approval is Barangay Resolution No. 21, Series of 2020 of Estancia, Narvacan "A Resolution Approving the Implementation of the Alloted 10% Youth Development Fund of One Hundred Fifty Seven Thousand Two Hundred Eighty Two Pesos Only for the Following Youth Programs, Projects and Activities for the Budget Year 2021";

WHEREAS, Section 57 (a) of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides for the review of barangay ordinances by the Sangguniang Panlungsod or Sangguniang Bayan as to whether the ordinance is consistent with law and city or municipal ordinances;

WHEREAS, Section 57 (c) of the same Act provides that if the Sangguniang Panlungsod or Sangguniang Bayan, as the case may be, finds the barangay ordinances inconsistent with law or city or municipal ordinances, the sanggunian concerned shall, within thirty (30) days from receipt thereof, return the same with its comments and recommendations to the sangguniang barangay concerned for adjustment, amendment, or modification; in which case, the effectivity of the barangay ordinance is suspended until such time as the revision called for is effected;

WHEREAS, Barangay Resolution No. 21, Series of 2020 of Estancia, Narvacan is not contrary to any existing law, rules and regulations and that the enactment of the Barangay Resolution is within the power, duties and functions of the Barangay Council of Estancia, Narvacan;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve Barangay Resolution No. 21, Series of 2020 of Estancia, Narvacan "A Resolution Approving the Implementation of the Allotted 10% Youth Development Fund of One Hundred Fifty Seven Thousand Two Hundred Eighty Two Pesos Only for the Following Youth Programs, Projects and Activities for the Budget Year 2021";
