RESOLUTION NO. 150 Series of 2020

A RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 001, SERIES OF 2020 OF DINALAOAN, NARVACAN "AN ORDINANCE APPROPRIATING FUNDS FOR BARANGAY GOVERNMENT OF DINALAOAN, NARVACAN, CALENDAR YEAR 2021"

WHEREAS, submitted to the Sangguniang Bayan of Narvacan for legislative review and approval is Barangay Appropriation Ordinance No. 001, Series of 2020 of Dinalaoan, Narvacan "An Ordinance Appropriating Funds for Barangay Government of Dinalaoan, Narvacan, Calendar Year 2021";

WHEREAS, Section 57 (a) of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides for the review of barangay ordinances by the Sangguniang Panlungsod or Sangguniang Bayan as to whether the ordinance is consistent with law and city or municipal ordinances;

WHEREAS, Section 57 (c) of the same Act provides that if the Sangguniang Panlungsod or Sangguniang Bayan, as the case may be, finds the barangay ordinances inconsistent with law or city or municipal ordinances, the sanggunian concerned shall, within thirty (30) days from receipt thereof, return the same with its comments and recommendations to the sangguniang barangay concerned for adjustment, amendment, or modification; in which case, the effectivity of the barangay ordinance is suspended until such time as the revision called for is effected;

WHEREAS, Barangay Appropriation Ordinance No. 001, Series of 2020 of Dinalaoan, Narvacan is not contrary to any existing law, rules and regulations and that the enactment of the Appropriation Ordinance is within the power, duties and functions of the Barangay Council of Dinalaoan, Narvacan;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve Barangay Appropriation Ordinance No. 001, Series of 2020 of Dinalaoan, Narvacan "An Ordinance Appropriating Funds for Barangay Government of Dinalaoan, Narvacan, Calendar Year 2021;

RESOLVED FINALLY that a copy of this Resolution be furnished to the Barangay Council of Dinalaoan, Narvacan for its information and guidance.
