**RESOLUTION NO. 142**

**A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND THE DEPARTMENT OF HEALTH (DOH) FOR THE IMMEDIATE RELEASE OF THE GRANT OF THE COVID-19 SPECIAL RISK ALLOWANCE (SRA) TO HEALTH WORKERS (HWs) OF NARVACAN, ILOCOS SUR**

**WHEREAS**, the Department of Budget and Management (DBM) and the Department of Health (DOH) issued Joint Circular No. 2, series of 2020, dated November 25, 2020 Guidelines on the Grant of the Covid-19 Special Risk Allowance (SRA) to Public and Private Health Workers (HWs);

**WHEREAS**, Administrative Order (AO) No. 36 dated November 16, 2020 authorizes the grant of a Covid-19 Special Risk Allowance (SRA) not exceeding P5,000 per month to public and private health workers (HWs) who are directly catering to or are in contact with Covid-19 patients in recognition of the heroic and invaluable contributions of HWs throughout the country who bravely and unselfishly risk their lives and health by being at the forefront of the national effort to address the public health emergency;

**WHEREAS**, Section 4(h) of RA No. 11494 or the Bayanihan to Recover as One Act authorized the national government to grant SRA to all public and private HWs directly catering to or in contact with Covid-19 patients for every month that they are serving during the state of national emergency as declared by the President;

**NOW THEREFORE**, in session assembled and on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the Department of Budget and Management (DBM) and the Department of Health (DOH) for the immediate release of the grant of the Covid-19 Special Risk Allowance (SRA) to Health Workers (HWs) of Narvacan, Ilocos Sur;

**RESOLVED FURTHER** to affirm the list of Health Workers (HWs) of this Municipality who shall be entitled to receive the Covid-19 Special Risk Allowance (SRA);

**RESOLVED FINALLY** that copies of this Resolution be forwarded to the Department of Budget and Management (DBM) and the Department of Health (DOH) for their information and appropriate actions.
