EXCERPTS FROM THE MINUTES OF THE 48TH REGULAR SESSION OF THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR HELD ON DECEMBER 14, 2020 AT THE MUNICIPAL SESSION HALL

RESOLUTION NO. 141 Series of 2020

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND THE DEPARTMENT OF HEALTH (DOH) FOR THE IMMEDIATE RELEASE OF THE GRANT OF THE COVID-19 ACTIVE HAZARD DUTY PAY (AHDP) TO FRONTLINE HUMAN RESOURCES FOR HEALTH (HRHs) OF NARVACAN, ILOCOS SUR

WHEREAS, the Department of Budget and Management (DBM) and the Department of Health (DOH) issued Joint Circular No. 1, series of 2020, dated November 25, 2020 Guidelines on the Grant of the Covid-19 Active Hazard Duty Pay (AHDP);

WHEREAS, Administrative Order (AO) No. 35 dated November 16, 2020 authorizes the grant of an Active Hazard Duty Pay (AHDP) not exceeding P3,000 per month to frontline Human Resources for Health (HRHs) whose services are essential in the fight against Covid-19 and are exposed to health risks and hazards due to the pandemic;

WHEREAS, Section 4(w) of RA No. 11494 or the Bayanihan to Recover as One Act authorized the national government to grant AHDP to all HRHs, such as medical and allied medical staff, serving in the frontlines during the Covid-19 state of national emergency;

NOW THEREFORE, in session assembled and on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the Department of Budget and Management (DBM) and the Department of Health (DOH) for the immediate release of the grant of the Covid-19 Active Hazard Duty Pay (AHDP) to frontline Human Resources for Health (HRHs) of Narvacan, Ilocos Sur;

RESOLVED FURTHER to affirm the list of Human Resources for Health (HRHs) of this Municipality who shall be entitled to receive the Covid-19 Active Hazard Duty Pay (AHDP);

RESOLVED FINALLY that copies of this Resolution be forwarded to the Department of Budget and Management (DBM) and the Department of Health (DOH) for their information and appropriate actions.
