RESOLUTION NO. 140

A RESOLUTION ADHERING TO THE USUAL ACCOUNTING AND AUDITING RULES AND REGULATIONS IN THE GRANT OF COMMUNICATION ALLOWANCE TO QUALIFIED MUNICIPAL OFFICIALS AND DEPARTMENT HEADS OF THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, the Local Government Unit of Narvacan, in its desire to improve and better services to its constituents, deems it necessary to provide communication allowance to qualified municipal officials and department heads as this is of great help in the facilitation of transactions and in the delivery of basic services;

WHEREAS, there is an appropriation for communication allowance under the Annual Budget which is provided for the eleven (11) municipal officials and twelve (12) departments heads of this LGU;

WHEREAS, each official is entitled to P2,000 while each department head P1,000 communication allowance per month, respectively;

WHEREAS, Presidential Decree 1445 declares it is a policy that: "All resources of the government shall be managed, expended or utilized in accordance with law and regulations, and safeguard against loss or wastage through illegal or improper disposition, with a view to ensuring efficiency, economy and effectiveness in the operations of government";

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adhere to the usual accounting and auditing rules and regulations in the grant of communication allowance to qualified municipal officials and employees of the Local Government Unit of Narvacan, Ilocos Sur;

RESOLVED FURTHER that upon urgent certification of the Municipal Mayor and on motion unanimously approved suspending the rule on the 3-day reading of Resolutions, this Resolution shall take effect immediately upon approval;

RESOLVED FINALLY that copies of this Resolution be forwarded to the Commission on Audit (COA) and to all persons and parties concerned for their information and appropriate actions.
