RESOLUTION NO. 129

Series of 2020

A RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT OF ILOCOS SUR, HEADED BY THE HONORABLE RYAN LUIS V. SINGSON, GOVERNOR, FOR THE CONSTRUCTION OF BULANOS-MARGAAY BRIDGE, THIS MUNICIPALITY

WHEREAS, Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991 delegates functions and responsibilities to Local Government Units (LGUs), primarily on the effective and efficient delivery of services and facilities at the local level;

WHEREAS, RA No. 7160 specifies the provision of fund assistance to LGUs in order to alleviate their financial burdens in carrying out the devolved functions and responsibilities;

WHEREAS, the Municipality of Narvacan desires to implement the **construction of Bulanos-Margaay Bridge** which is a local priority project congruent with the socio-economic and development agenda of the national government;

WHEREAS, the Municipality of Narvacan lacks the financial capability to implement the above-mentioned project that needs an estimated funding of Twenty Million Five Hundred Thousand Pesos (P20,500,000.00);

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the Provincial Government of Ilocos Sur, headed by the **HONORABLE RYAN LUIS V. SINGSON**, Governor, for the construction of Bulanos-Margaay Bridge, this Municipality;

RESOLVED FURTHER that upon motion unanimously seconded and adopted, the 3-day requirement on the passage of a resolution is hereby waived and shall take effect immediately upon approval;

RESOLVED FINALLY that copies of this Resolution be forwarded to the **HONORABLE RYAN LUIS V. SINGSON**, Governor, Province of Ilocos Sur, and to all persons and parties concerned for their information and appropriate actions.
