**A RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO DONATE IN FAVOR OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) THE 1,000 SQUARE METER PORTION OF A PARCEL OF LAND LOCATED AT BRGY. TUROD, NARVACAN UNDER TAX DECLARATION NO. 14-0033-00062 REGISTERED IN THE NAME OF THE MUNICIPALITY OF NARVACAN**

**WHEREAS**, Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provide the function of the Local Government Unit to ensure the delivery of basic services and the effective provision of facilities intended primarily to cater to the needs of the residents of the municipality;

**WHEREAS**, the Bureau of Jail Management and Penology (BJMP), in its mandate to direct, supervise and control the administration and operation of all district, city and municipal jail nationwide with pronged task of safekeeping and development of inmates requested from this Municipality a certain parcel of land for the construction of its jail building located at Brgy. Turod;

**WHEREAS**, in its desire to assist and support the BJMP in its programs and projects, the Municipality donates the requested parcel of lot particularly described as: **portion of Lot 1477, Cad 623-D under Tax Declaration No. 14-0033-00062 and designated as Lot 1477-A with an area of 1,000square meters located at Turod, Narvacan, Ilocos Sur,**

**WHEREAS**, the construction of the BJMP Station shall ultimately redound to the benefit of the inmates living safely in consonance with the objective of the BJMP to improve the living conditions of the offenders, enhance rehabilitation and reformation in preparation for their eventual reintegration into the mainstream of society upon their release, and professionalize jail services;
