A RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO DONATE IN FAVOR OF THE PHILIPPINE NATIONAL POLICE (PNP) THE 1,107 SQUARE METER PORTION OF A PARCEL OF LAND LOCATED AT BRGY. MARGAAY, NARVACAN COVERED BY TCT NO. 024-2019000447 REGISTERED IN THE NAME OF THE MUNICIPALITY OF NARVACAN

WHEREAS, Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provide the function of the Local Government Unit to ensure the delivery of basic services and the effective provision of facilities intended primarily to cater to the needs of the residents of the municipality;

WHEREAS, the Philippine National Police, in its mandate to efficiently and effectively enforce the law, prevent and control crimes, maintain peace and order, and ensure public safety and internal security, requested from this Municipality a certain parcel of land for the extension of its headquarters located at Brgy. Margaay;

WHEREAS, in its desire to assist and support the PNP in its programs and projects, the Municipality donates the requested parcel of lot particularly described as: portion of Lot 2 of Psd-01-099622, Cad 623-D under TCT No. 024-2019000447 with Tax Declaration No. 14-0018-02041 and designated as Lot 2-C containing an area of 1,107 square meters located at Margaay, Narvacan, Ilocos Sur,

WHEREAS, the extension of the PNP Station shall ultimately redound to the benefit of the citizens living in a peaceful and orderly locality in consonance with the objective of the PNP to serve and protect the citizenry to the fullest;
