A RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE IDENTIFIED PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR TO BE FUNDED BY THE LOCAL GOVERNMENT SUPPORT FUND - COVID-19 FINANCIAL ASSISTANCE (LGSF-COVID-19 FA) TO LOCAL GOVERNMENT UNITS IN THE BAYANIHAN TO RECOVER AS ONE ACT, REPUBLIC ACT NO. 11494

WHEREAS, under Section 4(q) of the "Bayanihan to Recover as One Act", Republic Act (RA) No. 11494, PhP 1,500,000,000.00 was appropriated to the Local Government Support Fund (LGSF) to provide financial assistance to Local Government Units (LGUs) in their local anti-Covid efforts;

WHEREAS, Budget Secretary WENDEL E. AVISADO issued Local Budget Circular 128 dated September 17, 2020, which laid out the guidelines and procedures on the release and utilization of the LGSF-Covid-19 Financial Assistance to LGUs (LGSF-Covid-19 FA to LGUs) consistent with the "Bayanihan to Recover as One Act", RA No. 11494;

WHEREAS, one of the requirements for the release of the LGSF-Covid -19 FA to LGUs Fund is a Sangguniang Bayan Resolution endorsing to the Department of Budget and Management the programs, projects, and activities (PPAs) being identified for implementation;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to endorse to the Department of Budget and Management (DBM) the identified programs, projects and activities (PPAs) of the Municipality of Narvacan, Ilocos Sur to be funded by the Local Government Support Fund-Covid-19 Financial Assistance (LGSF-Covid-19 FA) to Local Government Units in the Bayanihan to Recover as One Act, Republic Act No. 11494, to wit:
