

**RESOLUTION NO. 121**  
Series of 2020

**A RESOLUTION HONORING AND CELEBRATING THE CENTENNIAL ANNIVERSARY OF NARVACAN NORTH CENTRAL SCHOOL (NNCS), SIMPLY KNOWN AS THE GABALDON, LOCATED IN BRGY. MARGAAY, THIS MUNICIPALITY**

**WHEREAS**, Narvacan North Central School (NNCS), simply known as the Gabaldon, was erected in 1920 under the design of William E. Parsons, an Architect and City Planner known for his works in the Philippines during the early period of American colonization in the country;

**WHEREAS**, NNCS was built under Act No. 1801 or the Gabaldon Law, a legislation written by Isaura Gabaldon of the Philippine Assembly in 1907. The law provided for the funding of P 1M for the construction of modern public schools across the Philippine Islands;

**WHEREAS**, Republic Act No. 11194 "An Act Mandating the Conservation of Gabaldon School Buildings Nationwide, Providing Penalties for Violations, and Appropriating Funds Therefore" recognized all Gabaldon school buildings as built heritage and included them as part of cultural properties under Republic Act No. 10066 or the National Cultural Heritage Act of 2009 which provides for the protection and conservation of the National Cultural Heritage;

**WHEREAS**, this year 2020, NNCS celebrates its 100 years of protecting and promoting the right of every student to quality, equitable, culture-based, and complete basic education;

**WHEREAS**, the Sangguniang Bayan of Narvacan takes great pleasure in paying tribute to NNCS for reaching 100 years of existence, of positive influence, of shaping the next generation and of fostering responsible citizenry and leadership;

**NOW THEREFORE**, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to honor and celebrate the centennial anniversary of Narvacan North Central School (NNCS), simply known as the Gabaldon, located in Brgy. Margaay, this Municipality;

**RESOLVED FURTHER** that upon motion unanimously seconded and adopted, the 3-day requirement on the passage of a resolution is hereby waived and shall take effect immediately upon approval;

**RESOLVED FINALLY** that a copy of this Resolution be handed to the Administration of Narvacan North Central School, represented by MR. PEREGRINO CAC, Principal III, for the school's information and acceptance.
