A RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ILOCOS SUR COMMUNITY COLLEGE (ISCC) FOR THE DISTRIBUTION TO AND COLLECTION OF EDUCATIONAL MATERIALS AND RESOURCES FROM THE SCHOOL'S STUDENTS WHO ARE RESIDENTS OF THIS MUNICIPALITY

WHEREAS, Ilocos Sur Community College (ISCC) is offering various technical-vocational and professional courses as authorized by the Commission on Higher Education (CHED) and the Technical Education and Skills Development Authority (TESDA);

WHEREAS, amidst the challenges of Covid-19, ISCC continues to provide quality education to its students using flexible learning modalities and resources and classes for the first semester of the School Year 2020-2021;

WHEREAS, ISCC recognizes the need to facilitate contact with students who are residing in areas under ECQ, MECQ and GCQ where individuals who are 20 years and below are not allowed to go out of their residences;

WHEREAS, ISCC proposed that its instructors and staff be allowed to bring educational materials and resources, at least twice a month, to the Local Government Unit of Narvacan, Ilocos Sur which shall distribute and collect the same from the school's students who are residing in this Municipality;

WHEREAS, this LGU accepted and approved the proposal and agreed to allow instructors and staff of ISCC in support of its educational undertaking;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **HONORABLE LUIS "CHAVIT" C. SINGSON**, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) with Ilocos Sur Community College (ISCC) for the distribution to and collection of educational materials and resources from the school's students who are residents of this Municipality;
