**RESOLUTION NO. 107**

**A RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ILOCOS SUR HEADED BY THE HONORABLE RYAN V. SINGSON, GOVERNOR, TO PROVIDE FINANCIAL ASSISTANCE FOR THE CONSTRUCTION OF SAN PEDRO BRIDGE LOCATED AT BARANGAY SA PEDRO, THIS MUNICIPALITY**

**WHEREAS**, the Municipal Administration identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

**WHEREAS**, the Municipal Administration included in these priority projects the construction of San Pedro Bridge located at Barangay San Pedro, this Municipality;

**WHEREAS**, this goal, however is constrained by financial limitation prompting the Municipal Administration and the Sangguniang Bayan to seek assistance from the Provincial Government in order to get things moving in a positive direction and to serve as a follow up point for pursuing the development efforts of LGU Narvacan;

**WHEREAS**, the Municipal Administration needs development funds to finance the construction of San Pedro Bridge that needs a funding estimate of Seven Million Five Hundred Thousand Pesos (P7,500,000.00)

**WHEREAS**, when fully realized, the said project will provide convenient transportation, better and faster means of transporting farm products to the market, and promote inter-trade relations among neighboring barangays, thus, enhancing economic growth and development of the whole community;

**WHEREAS**, the Executive and Legislative Bodies of Narvacan, Ilocos Sur always trust in the sincere concern of the Provincial Government in extending assistance for the realization of municipal development projects which will redound to the benefit and good of the people and the municipality;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the Provincial Government of Ilocos Sur headed by the **HONORABLE RYAN V. SINGSON**, Governor, to provide financial assistance for the construction of San Pedro Bridge located at Barangay San Pedro, this Municipality;

**RESOLVED FURTHER** that upon urgent certification of the Municipal Mayor and on motion unanimously approved suspending the rule on the 3-day reading of Resolutions, this Resolution shall take effect immediately upon approval;

**RESOLVED FINALLY** that a copy of this Resolution be forwarded to the Provincial Government headed by the **HONORABLE RYAN V. SINGSON**, Governor, for its information and appropriate action.
