## **RESOLUTION NO. 106**

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. LUIS "CHAVIT" C. SINGSON TO APPLY FOR THE ISSUANCE OF A TEMPORARY PERMIT FOR THE COMMUNITY FISH LANDING CENTER (CFLC) BUILT IN THIS MUNICIPALITY

**WHEREAS**, the Municipality of Narvacan had been preselected as one of the recipients of fishery post-harvest infrastructure/facility in the form of a Community Fish Landing Center (CFLC) established under the Bureau of Fisheries and Aquatic Resources (BFAR) Target Program to reduce poverty and generate economic transformation, hasten access to markets to reduce post fishing-harvest losses and providing improve science-based monitoring of the condition of the fishing ground and fishery resources for the fisherfolks in the municipality;

**WHEREAS**, the building site of the CFLC Facility as determined by LGU Narvacan is on a parcel of land located on the shoreline of Brgy. Sulvec, Narvacan, Ilocos Sur;

**WHEREAS**, the Department of Environment and Natural Resources issued DENR Land Administrative Order 8-3 governing the Rules and Regulations in the Issuance of Temporary Permits of occupation and use of Non-mineral, Non-timber Public Lands, and of Lands and other Real Properties of the Commonwealth of the Philippines to legalize the occupancy of LGUs in the area for them to introduce improvements therein;

**WHEREAS**, subject to the above condition, LGU Narvacan must conform and provide the necessary permits for the above subject property in order to be compliant;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to grant authority to the Hon. Mayor Luis "Chavit" C. Singson to apply for a temporary permit over the area where the Community Fish Landing Center (CFLC) is located in Brgy. Sulvec, Narvacan, Ilocos Sur.

**RESOLVED FURTHER,** that copies of this Resolution be furnished to the Bureau of Fisheries and Aquatic Resources Regional Office 1 and the Philippine Fisheries and Development Authority for their information, guidance and reference.
