RESOLUTION NO. 101

Series of 2020

A RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE RESOLUTION NO. 5 -LCS, SERIES OF 2020 "A RESOLUTION FOR THE REALIGNMENT OF FUNDS OF THE PROGRAMS, PROJECTS, AND ACTIVITIES OF THE 20% DEVELOPMENT FUND FOR CY 2020 AND FAVORABLY ENDORSING THE SAME TO THE SANGGUNIANG BAYAN OF NARVACAN FOR APPROVAL"

WHEREAS, President Rodrigo Roa Duterte issued Presidential Proclamation No. 922 declaring a "State of Public Health Emergency" and further issued Presidential Proclamation No. 929, Series of 2020 declaring a "State of Calamity" throughout the Philippines due to Covid-19;

WHEREAS, both Proclamations enjoined all government agencies and LGUs to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake crucial, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of Covid-19;

WHEREAS, DILG and DBM Joint Memorandum Circular 01 "Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in View of the Coronavirus Disease 2019 (Covid-19) Situation" provides procedures on the use of the 20% Development Fund to give LGUs greater leeway and flexibility in the utilization of funds for their disaster preparedness and response efforts to contain the spread of Covid-19, and to continue to provide basic services to the affected population;

WHEREAS, because of the Covid-19 Crisis affecting the entire Nation, there is an imperative need to include the Narvacan Covid-19 Response (Programs, Projects, and Activities) among the Municipality's priorities for the current year in order to rationalize the allocations for various programs, projects, and activities to curtail and eliminate the threat of Covid-19 in the Municipality of Narvacan;

WHEREAS, presented for consideration of the Sangguniang Bayan of Narvacan, Ilocos Sur is Executive Committee Resolution No. 5-LCS, Series of 2020 of the Municipal Development Council (MDC) entitled "A Resolution for the Realignment of Funds of the Programs, Projects and Activities of the 20% Development Fund for CY 2020 and Favorably Endorsing the Same to the Sangguniang Bayan of the Municipality of Narvacan for Approval".
